ON 06/29/2025, WHILE ON PATROL IN THE AREA OF 17327 W HIGHWAY 329, I DROVE PAST A NEW, PARTIALLY CONSTRUCTED BARNDOMINIUM. THE PROPERTY HAD FENCING AND NO GATE WAS PRESENT/CLOSED. DIRECTLY IN FRONT OF THE BARNDOMINIUM, I OBSERVED A SILVER HONDA CAR PARKED WITH ITS RUNNING LIGHTS ON.

THE VEHICLE BORE FLORIDA TAG CD01ED. THE VEHICLE WAS OCCUPIED BY A BLACK MALE, LATER IDENTIFIED AS SUBJECT FREDDIE JACKSON JR, AND BLACK FEMALE, IDENTIFIED AS SUBJECT NAVONGELA JACKSON. SUBJECT FREDDIE JACKSON JR INITIALLY COMPLIED AND PROVIDED HIS FLORIDA CDL TO ME. SUBJECT FREDDIE JACKSON JR ADVISED THEY LIVED AT THE LOCATION, BUT THEIR LISTED ADDRESS SHOWED 17335 W HIGHWAY 329.

AS I BEGAN TO RUN SUBJECT FREDDIE JACKSON JR'S LICENSE NUMBER/ LICENSE PLATE, HE EXITED HIS VEHICLE AND STOOD NEXT TO THE OPEN DRIVER DOOR. SUBJECT FREDDIE JACKSON JR REFUSED TO RE-ENTER HIS VEHICLE AND DEMANDED I LEAVE HIS PROPERTY AND I WAS TRESPASSING. AFTER SEVERAL COMMANDS FOR SUBJECT FREDDIE JACKSON JR TO RETURN INTO HIS VEHICLE AND HIM REFUSING TO DO SO, I DETAINED HIM IN AGENCY HANDCUFFS AND PLACED HIM IN THE REAR OF MY PATROL VEHICLE.

DURING MY VERBAL EXCHANGE WITH SUBJECT FREDDIE JACKSON JR, SUBJECT NAVONGELA JACKSON CONTINUED TO REFUSE TO PROVIDE ME WITH AN I.D. SUBJECT NAVONGELA JACKSON CALLED 911 AND ASKED FOR ANOTHER DEPUTY TO RESPOND DUE TO ME "ARRESTING" HER HUSBAND.

UPON FURTHER INSPECTION, I OBSERVED A MAILBOX IN FRONT OF THE PROPERTY TO HAVE THE NUMERIC 17335, BUT THE FENCE TO HAVE 17327. A "JOB BOX" CONTAINING THE PROPERTY OWNERS INFORMATION WAS LOCATED ON THE NORTH SIDE OF THE PROPERTY. I WAS ABLE TO VERIFY BOTH SUBJECTS WERE LISTED AS OWNERS OF THE PROPERTY.



THIS NARRATIVE WAS WRITTEN TO PROVIDE FURTHER DETAILS TO THE INCIDENT.

ON 06/29/2025, WHILE ON PATROL IN THE AREA OF 17327 W HIGHWAY 329, I DROVE PAST A NEW, PARTIALLY CONSTRUCTED BARNDOMINIUM. THE PROPERTY HAD FENCING AND THE GATE WAS OPEN. DIRECTLY IN FRONT OF THE BARNDOMINIUM, I OBSERVED A SILVER HONDA CAR PARKED WITH ITS RUNNING LIGHTS ON.

THE VEHICLE BORE FLORIDA TAG CD01ED. THE VEHICLE WAS OCCUPIED BY A BLACK MALE, LATER IDENTIFIED AS SUBJECT FREDDIE JACKSON JR, AND A BLACK FEMALE, IDENTIFIED AS SUBJECT NAVONGELA JACKSON.

UPON CONTACT WITH THE SUBJECTS, I INQUIRED IF THEY OWNED THE PROPERTY, TO WHICH SUBJECT FREDDIE JACKSON JR RESPONDED WITH "WE HERE AINT WE, WHAT YOU THINK?" I ASKED SUBJECT FREDDIE JACKSON JR TO PROVIDE AN I.D. SO HE COULD BE IDENTIFIED AS THE HOME/ PROPERTY OWNER. MULTIPLE TIMES, SUBJECT FREDDIE JACKSON JR REFUSED TO PROVIDE I.D. TO ME. SUBJECT FREDDIE JACKSON JR THEN

DEMANDED I GET OFF HIS PROPERTY IMMEDIATELY. SUBJECT NAVONGELA JACKSON TOLD SUBJECT FREDDIE JACKSON JR TO PROVIDE HIS ID TO ME, AT WHICH TIME HE DID.

I OBSERVED SUBJECT FREDDIE JACKSON JR'S I.D. TO HAVE A CLOSELY RELATED NUMERICAL TO THE CURRENT ADDRESS, BUT IT STILL DID NOT IDENTIFY HIM AS THE HOMEOWNER.

I ATTEMPTED TO EXPLAIN WHY I WAS AT THIS LOCATION AND WHY I STOPPED OUT WITH THEM, BUT SUBJECT FREDDIE JACKSON JR CUT ME OFF/ INTERRUPTED ME BEFORE I WAS ABLE TO.

AS I BEGAN TO RUN SUBJECT FREDDIE JACKSON JR'S LICENSE NUMBER/ LICENSE PLATE, HE EXITED HIS VEHICLE AND STOOD NEXT TO THE OPEN DRIVER DOOR. SUBJECT FREDDIE JACKSON JR REFUSED TO RE-ENTER HIS VEHICLE AND DEMANDED I LEAVE HIS PROPERTY AND STATED I WAS TRESPASSING. AFTER SEVERAL COMMANDS FOR SUBJECT FREDDIE JACKSON JR TO RETURN INTO HIS VEHICLE AND HIM REFUSING TO DO SO, I DETAINED HIM IN AGENCY HANDCUFFS AND PLACED HIM IN THE REAR OF MY PATROL VEHICLE.

DURING THE INCIDENT, SUBJECT NAVONGELA JACKSON CALLED 911 AND REQUESTED ANOTHER DEPUTY RESPOND DUE TO HER BELIEVING I WAS TRESPASSING ON HER PROPERTY AND "ARRESTING" HER HUSBAND. SUBJECT FREDDIE JACKSON JR WAS ONLY BEING DETAINED AND WAS NOT AT ANY TIME UNDER ARREST DURING THIS INCIDENT.

UPON FURTHER INSPECTION, I OBSERVED A MAILBOX IN FRONT OF THE PROPERTY TO HAVE THE NUMERIC 17335, BUT THE FENCE TO HAVE 17327 ON IT. A "JOB BOX" CONTAINING THE PROPERTY OWNERS INFORMATION WAS LOCATED ON THE NORTH SIDE OF THE PROPERTY. I WAS ABLE TO VERIFY BOTH SUBJECTS WERE LISTED AS OWNERS OF THE PROPERTY.

I THEN RELEASED SUBJECT FREDDIE JACKSON JR FROM CUSTODY.

DUE TO DISCOVERING SUBJECT FREDDIE JACKSON JR WAS STATING THE TRUTH AND WAS INDEED THE OWNER, NO PROBABLE CAUSE EXISTS FOR HIS ARREST.

DURING THE PAST YEAR, THERE HAVE BEEN 121 "CONSTRUCTION RELATED" OFFENSE REPORTS WITH MANY THEM BEING BURGLARIES AND CRIMINAL MISCHIEFS.
