SYNOPSIS

NARRATIVE

On 10/17/2025 at approximately 1713 hours, I was dispatched to 642 W Raymond St in reference to a disturbance.

Upon arrival I made contact with Martin Gomez who advised me he is working on the residence mentioned above. Martin advised while he was inside working his daughters were in the front porch playing on their phone. Martin advised one of his daughters ran inside and told him someone is staring at her. Martin advised the moment he stepped out side the man staring later Identified as Michael Henry said what do we have a problem. Martin advised he asked Michael if he was talking to his kids or to him. Martin advised Michael responded with "what I cant look over my own wall" and started talking "shit". Martin advised he started walking toward the wall and Michael stepped on to the drive way saying if you step closer there will be a problem. Michael advised Martin he owns a foot past the wall. Martin advised he is calling the cops and that ended the disturbance.

I attempted to make contact with Michael on scene but Michael did not want to speak with me. After I was unable to contact Michael I advised him through the door he was going to receive charges for disorderly contact.

Sergeant Fulton #88 made phone contact with Michael and was able to get his side of the situation please see his supplement report for the interview with Michael.

PRIMARY OFFENSE:

Disorderly Conduct

NARRATIVE

On 10/18/2025 I contacted Michael and Jennifer Henry in regard to a complaint they had on Ofc. Calloway #141. Upon speaking with Michael he advised me he wanted to pursue charges on Ofc. Calloway for trespassing, due to him knocking, banging, ringing the door bell, and yelling through the front door of the residence for approximately 12 minutes straight. Michael explained this all occurred after he told Ofc. Calloway that he did not want to speak with officers in regard to the incident he had with the construction worker next door.

Michael was upset because he was told by Ofc. Calloway, he was going to be charged with Disorderly conduct if he did not come speak with him. I informed Michael, Ofc. Calloway had a right to threaten the charge of disorderly conduct and by not getting his side of the story, it is the only option Ofc. Calloway had due to only having the statements made by the reporting party. I informed Michael, the act of a police officer knocking at the front door and yelling for that matter is not a violation of ARS 13-1504 Trespassing.

It was at this time Michael became argumentative, stating the Coolidge Police Department was using "direct enforcement" to take action against him and his wife for previous complaints. I informed him the notion of that is preposterous. To insinuate that we (Coolidge Police Department) used the construction worker (Reporting Party) as our agent or any other previous caller that has reported disruptive behavior by Michael Henry is non factual and outlandish. Michael continued to argue with me and was told that if he wished to file a formal complaint he had every right to do so. It was at this time Michael handed the phone to his wife Jennifer and I briefly spoke with her.

Jennifer wished to engage in civil conversation and speak about the actions from what occurred between her husband Michael and the construction worker next door on 10/17/2025. She informed me of the following.

Jennifer and Michael Henry came home to their residence located at 564 W. Raymond St. When they pulled into their driveway they observed two unattended kids playing in the front yard of the the residence next door. The car door that was in the driveway of said residence was wide open and there was loud "bass music" playing. She advised Michael exited their vehicle and looked over at the two children playing.

During this time the little girl went running into the residence screaming dad someone is looking at me. A few seconds later while Michael was still standing in his yard the construction worker exited the residence stating "what the fuck are you looking at old man, do you guys have a problem". She said Michael stated "I don't know your daughter is the one that had you called out here". Jennifer told me there was a brief argument back and forth between Michael and the construction worker. Michael telling the guy not to leave his kids unattended and the construction worker telling Michael that he was working. During this argument Jennifer told me, the construction worker began aggressively approaching

Michael who was at his fence while Michael advised him, if he came any further he was going to be trespassing. I asked her how the construction worker was being aggressive and she said he was yelling fuck you and kept calling Michael an old man. The argument ended with the construction worker stating he was going to call the police.

Jennifer told me her and Michael went back into their residence and immediately contacted the construction workers boss in regards to what just occurred and for the noise being omitted from the residence while he worked. She then said, while on the phone with the construction companies boss Ofc. Calloway arrived on scene and began knocking on the front door repetitively and would not leave even after being told they do not want to speak with him. She said Ofc. Calloway's behavior was unprofessional argumentative and not necessary. Jennifer continued to tell me there was no reason for the police to have to intervene, stating the incident was blown way out of proportion by the construction worker.

She simply said there was a small maybe three minute exchange of words, no one was threatened, and there was nothing physical that occurred. Jennifer explained that if anyone's behavior was disorderly it was that of the construction workers, for being "a bad dad". That concluded my conversation with Jennifer.

I spoke with Michael once more who informed me he believed the whole incident should have been deescalated by Ofc. Calloway as just a small neighbor dispute but instead he inflamed it into something it was not. I informed him once more about his rights to file a formal complaint on Ofc. Calloway and that I did not know the other side of the incident as I was not the responding officer at the time of the incident. Michael told me he did not wish to file a formal complaint on Ofc. Calloway just wanted me to speak with him. I informed him as of now, no policies or laws were broken by Ofc. Calloway, and no further investigation in regard to his "unprofessionalism" was going to be investigated unless a formal complaint was completed.

Michael then asked him if he could pursue charges on the construction worker for disorderly conduct. I informed him he had a right to request it and I would forward the information on to Ofc. Calloway as the case agent on the case. I informed him once again, I did not know what was originally said at the time of the incident and I was unable to determine if the reporting party violated ARS 13-2904A1 disorderly conduct. Michael was told that would ultimately be decided by the case agent in this matter, Ofc. Calloway.

An email was sent to Ofc. Calloway regarding the information I just received from both Jennifer and Michael and that concludes my involvement in this matter.

Sgt Fulton #88 then spoke with Michael on the phone the following morning on 10/18/2025 to obtain his side of the situation which was documented in a supplement report to this case number.

I was able to speak with Michael my self on 10/18/2025 and was able to provide my work email address to him to send the photographs. Michael could not provide me fully the surveillance footage of the incident to review. The photographs provided were placed into the case file.
