On 03/18/2025 at approximately 2100 hours, I, Ofc. Campisi arrived at 3105 Cobb PKWY (Walmart) in reference to a male attempting to snatch a mother's baby. Upon my arrival, I met with the mother, who I identified as Caroline Miller, by being provided with her driver's license. Miller explained that while she was in Walmart, she was sitting on the handicap drivable shopping carts with her Juvenile 2 between her feet and holding her Juvenile 1. Miller explained that an Indian male approached her and asked about where the Tylenol was. Miller then explained that the male grabbed Juvenile 1 and started pulling Juvenile 1 away from her. Miller explained that she did not lose grasp of Juvenile 1, and that she pulled Juvenile 1 back. Miller explained that when she did this the male backed off. She then explained that she called her husband, and the male told her not to do that and then left. Walmart cameras showed the incident and Cpl. Lumpkin viewed the footage showing what Miller explained. Walmart also had footage of the male at the checkout, and Walmart employees provided me with his receipt, showing that the male used a VISA credit card to purchase Tylenol. I later submitted the receipt to an evidence locker at the Acworth Police Department as evidence. Walmart also showed me a picture of the male's vehicle in the parking lot of the Walmart, that the male left in, and it appeared to be a black sedan. I took a picture of the vehicle image and sent it to the Sgt. phone. A picture of the suspect on Walmart's footage was taken by the Sgt. phone by Cpl. Lumpkin. I was informed that the incident occurred at approximately 2020 hours and the suspect left the scene at approximately 2030 hours.

I then went to 3709 Anna Ct., Miller's residence to confirm that Juvenile 1 was not injured. Juvenile 1 was already at the residence due to being brought home by Juvenile 1's father. When I arrived at the residence, I met with Juvenile 1 and saw that Juvenile 1 appeared to not be injured. Miller checked Juvenile 1 for injuries and did not find any. I took a picture of Juvenile 1 and sent the picture to the Sgt. phone. I notified Miller that a detective would follow up on the case.

I checked FLOCK cameras around the Walmart, around the time that the suspect would have left in the black sedan and was not able to locate the suspect. A Walmart employee informed officers that they would be able to give a detective the footage the next day.
