At approximately 0407 hours on September 1, 2019, I arrived in the area of 4381 Senator Russell Avenue, which is located within the city limits of Acworth Georgia. I was responding to a third-party report of a possible rape in progress. The complainant, Jeremiah, told 911 operators that his girlfriend was being raped in her UBER ride. Upon arrival, I was able to make contact with the victim, later identified as Caroline Miller. I was also able to make contact with the suspect, later identified as Chadwick Foster. When asked what happened, Miller, who was visibly distraught and crying, stated that "he touched my pussy."

Miller stated that earlier in the evening, she had been given a ride home from the Center Street Tavern, located at the above-listed address. Miller stated that she had been drinking and could not drive her self home. Miller stated that sometime later, she felt she needed to retrieve her vehicle from Senator Russell Avenue because she had to work later today. Miller stated that she obtained a LYFT ride, and Foster was the assigned driver.

Miller stated that she fell asleep shortly after the ride began and woke up to realize they were not driving towards Center Street Tavern. Miller stated that Foster checked the address and it had been entered incorrectly for 519 Dallas Road, Dallas, Georgia, which is the address of Miller's boyfriend, Jeremiah. Miller stated that she offered to pay Foster more if he would go ahead and take her to Center Street, which did occur. Miller stated that during the ride, there was minimal general conversation. Miller also said that there was no mutual touching and that she never touched him at all. Miller also stated that Foster had asked if she wanted to go somewhere with him. Miller responded to him that she would but needed to get stuff out of her car first. Miller stated that she did this to get away from him.

According to Miller, she fell asleep again and woke up somewhere near Main Street and Lake Acworth Drive in Acworth. Miller stated that when she woke up, Foster had his hand on her upper thigh and continued rubbing her thigh as they drove. Sometime shortly after arriving in front of Center Street Tavern, Miller stated that Foster put his hand under her underwear and placed his finger near her vagina. Miller stated that no digital penetration occurred. Miller stated that during the time of the assault, she was texting her boyfriend and pleading with him to call the police. Screenshots of these texts were sent to the Shift Sergeant's phone to be added to this report. When asked why she did not call 911, Miller stated that she was scared.

Speaking with Foster, he stated that he had picked up Miller from her apartment in Cartersville. Foster stated that the first address they went to was 519 Dallas Road. According to Foster, upon arrival at this address, Miller did not see her boyfriend's car and wanted to go back to the bar and pick up her car. The GPS tracking for LYFT showed that Foster's vehicle had been in close proximity to the 519 Dallas Road address.

Foster's initial statement to me was that Miller had been coherent and conversational for the entire ride. When asked a second time, Foster altered his initial account of this portion of the event. Foster stated that during the part of the trip from Dallas to Acworth, he had stopped at the QT for a drink. Upon getting back in the car, Foster stated that Miller was laying down in the back seat and there was no conversation during this time. Foster stated that when they got back to Senator Russell Avenue location, they sat and talked.

Foster stated that he asked Miller if they could get a room, and he stated she told him yes. Foster then asked Miller if he could touch her, and he stated she told him yes. When asked if there was physical contact, Foster stated that he touched her leg and in between her legs. Foster also said that there was mutual touching during their time in the vehicle in front of Center Street. Foster stated that they agreed to get a room, but Miller said that she needed her charger out of her car before they went anywhere. A short time later was when I arrived.

Foster had made an initial statement to Corporal Guzowski who advised me that Foster had denied that there had been any physical contact between the two.

Both parties stated that they had never met before tonight.

Due to the totality of the circumstances, Foster was placed under arrest, and I secured warrant # 19-W-9171 for Sexual Battery (OCGA 16-6-22.1). Judge C. Fielder approved the warrant. A copy of the warrant was scanned and added to this report and another placed in records.


